1. Warm up time (10 min) is included in the 1:15 time slot for each match. Please begin your match when all players are warmed up and ready to play.
2. Traditional scoring for all games. Matches will consist of pro sets played to 10, with a tiebreaker game to 7. If your match is not over within the specified time, whoever is leading will be declared the winner.
3. The player with the best record at the end of the season will be league champion.
4. Report scores courtside following your match on a scoresheet.
5. If you are not able to play, you are responsible for finding an alternate on page 1.
6. Members (\$25) and non-members (\$35) are responsible to pay the league fee on or before the first night of play on July 12. Please pay at the Fitness Center desk in the basement of the Clark Sports Center and be sure to mention it is for the Men's Summer Tennis League.

In the event of inclement weather, a decision whether tennis will be canceled will be made around 4:30 pm. Please call the front desk at the Clark Sports Center at 547-2800 to find out if play will be suspended. If tennis is canceled on Monday night, we will make every attempt to play on Tuesday night at the same times. Tennis will be canceled for the week if there is inclement weather on both Monday and Tuesday nights.
